# Terms of Agreement

## SoulTempleBand Agrees to Provide:

1. A vocal/saxophone/piano/bass/drums quintet. Band attire black formalwear unless the bride requests otherwise.
2. Music from \_\_\_\_\_ to \_\_\_\_\_ on \_\_\_\_\_ at the \_\_\_\_\_ in \_\_\_\_\_, \_\_\_\_\_. The band generally plays a 40 minute dinner set with a 20 minute break for dinner, and 50 minute sets with ten minutes break each hour; this timing is flexible based on the needs of the occasion. If the band is asked to play longer than the time agreed upon in the contract, there will be an overtime charge of \_\_\_\_\_ per half hour.
3. An emcee to introduce the wedding party, first dance, and any important introductions or events during dinner and the reception.
4. Setup of musical equipment. Setup can begin as early as two hours before the performance at the discretion of the bride or her representative. All equipment will be set by thirty minutes before performance time. Additional fees may apply for early set up.
5. Tear down of musical equipment. All equipment will be cleared from the venue by one hour after the reception.

## Bride Agrees to Provide:

1. A non-refundable deposit of 25% (\_\_\_\_\_) to reserve the date. Cash, check, or money order. Mailing address: Doug Leaffer, 108 Hickory Hill Road, N. Andover, MA 01845. Returned checks are charged \$45.
2. The remainder of \_\_\_\_\_ by cash, check, or money order. Payment must be made on or before the performance begins.
3. Communication regarding any changes in timing, performance parameters, requested music, etc.
4. A written timeline on or before the wedding day, recognizing that some elements of the timeline may shift.

## Bride and Venue Agree to Provide:

1. A minimum performance area of 20 feet by 10 feet, preferably raised.
2. 2 Electrical outlets within 25 feet of the band.
3. Space for cases, gear, etc.
4. Meals for five band members.

SoulTempleBand's obligations hereunder are subject to detention by sickness, inability to perform, accident, accidents to means of transportation, Acts of God, riots, strikes, labor difficulties, epidemics, any act or order of any public authority or any other cause, similar or dissimilar beyond SoulTempleBand's control.

The Bride and SoulTempleBand, in signing this Agreement, or having signed by a representative, acknowledge her and their authority to do so and hereby assumes liability for the amount stated herein.
